I, _____ will provide this French Bulldog with a safe, loving home. If any abuse or neglect is suspected, including, but not exclusive to – dog is housed outside, living in a crate full time, lack of proper vet care, obvious malnutrition, repeated complaints of dog running loose or getting lost, charges or criminal investigations of abuse, neglect, or cruelty by any local animal shelter or law enforcement agency, etc. - breeder will have the right to confiscate and rehome said dog, and I will forfeit all rights of ownership to the animal without monetary compensation

I will have this French Bulldog examined by a licensed veterinarian of my choice within 5 working business days of purchase. If dog is deemed unhealthy or is diagnosed with any medical condition, I will receive a full cash refund upon return of the dog, paperwork, and vet records, to the breeder. After 5 days, the health contract will be in effect. All deposits are non-refundable.

I will return this French Bulldog to the breeder if at any point, and for any reason, I can no longer keep this dog, unless otherwise agreed upon by both parties. The breeder will make themselves available to address any questions or concerns I may have during the lifespan of the dog. If the dog falls ill or is injured, I understand that I may contact my breeder for any and all information that may assist in diagnosing and treating the condition.

If any disputes arise as a result of this contract, I understand that the breeder has the right to seek reimbursement for any legal expenses incurred. All disputes will be resolved via binding arbitration in Union County, Pennsylvania, USA.

The French Bulldog I am purchasing on _____ is a:

A) PET PUPPY _____

All pets are sold with LIMITED AKC REGISTRATION for non-breeding/non-showing dogs. Recommended sterilization for females is at 9-11 months; males, 18-24 months. Buyer is obligated by this contract to spay/neuter their dog within the recommended time frame

B) ADULT PET _____

If the pet has not already been spayed/neutered upon purchase (such as a retired breeding/showing dog), buyer is obligated by this contract to spay/neuter their dog within 3 months of purchase. Breeder will NOT release AKC registration papers, until this obligation has been met.

C) SHOW PROSPECT MALE _____

This puppy is / is not on a co-ownership with the breeder until terms are met – terms are 2 series of 3 semen collections which results in two pregnancies. Breeder will sign off as co-owner once terms are met.

D) SHOW PROSPECT FEMALE _____

This puppy is / is not on a co-ownership with the breeder until terms are met – terms are 2nd pick puppy from first litter. Breeder will sign off as co-owner once terms are met.
